Assumption of Risks

I am aware that the sport of Ringette or recreation of Ringette has many inherent and other risks. I have discussed with and explained to my above child the risks. I and my child freely accept and fully assume all such risks (both legal and physical), dangers and hazards, whether known or unknown and the possibility of personal injury, death, property damage or loss resulting from them.

Waiver of Claims and Indemnity Agreement

I agree as follows:

To waive any and all claims that I may have or may have in the future against the Northwest Ringette Amalgamation and its members, officers, directors, employees, agents, insurers and assigns (all of whom are hereinafter collectively referred to as the Releasees) as a result directly or indirectly of my child's participation in the sport or recreation of Ringette.

To release the Releasees from any and all liability for any loss, damage, injury or expense that I may suffer or that my family may suffer, as a result, directly or indirectly, of my above named child's participation in the sport or recreation of Ringette due to any cause whatsoever including negligence, gross negligence, breach of contract or breach of any statutory or other duty of care, including any duty of care owed under the Occupiers' Liability Act, R.S.A. 1980, c. O-3 as amended on the part of the Releasees.

To hold harmless and indemnify the Releasees from any and all liability for any loss, damage, injury or expense suffered by any other person or by my above named child as a result, directly or indirectly, of that child's participation in the sport of or recreation of Ringette.

I have read and understood this agreement and I am aware that by signing this agreement, my child and I are waiving certain legal rights, which we may have against the Releasees and I am accepting certain responsibilities to the release.
